## **FINANCIALS:**

• Operating Income ended with a surplus of \$12,975.81.

- Surplus target for 2020, to cover long term expenses, is \$26,550.00. We are on pace for annual surplus of \$31,142.00, 117% of target.
- Umpqua Bank Accounts: \$5,413.87 in operating account and \$53,403.10 in reserve account, Totaling = \$58,816.97.
- Accounts receivable stands at -\$2,105.84: \$2,893.31 is paid in advance and \$787.47 is past due.

#### **NEW BUSINESS:**

- Vial Fotheringham LLP Webinar regarding Gov. Inslee's Proclamations 20-05 & 20-51
  - Covered specific concerns & questions from HOA Board members and homeowners
  - Main Takeaways
    - The Association and Board's job is to enforce the CCR's & Bylaws. It is NOT their job to enforce federal, state, or local laws;
    - It is ok to report possible illegal activity, it is not okay to enforce as we are not the police or the government;
    - Our duty is to the homeowners as such our focus will be kept deliberately narrow;
    - Use common sense
      - Example: If RV's or temporary dwellings are needed due to special quarantine measures for COVID-19 work with the homeowners on these measures.
- The paperwork is into our bank to have signatures changed; we are waiting on the bank for signature cards.
- April will be contacting Frontier Landscaping to discuss contract items that are not being performed, such as weeding, pruning, edging, and the quality of the actual mowing.
- Homeowner complaints from Christopher MacIntosh have been addressed and hopefully the issues have been resolved between homeowners.
